

**By the Judgement of 15 December 2023 No.58-II, the Constitutional Court assessed constitutionality of Article 16<sup>1</sup> (item 6) of the Federal Law “On Compulsory Insurance of Civil Liability of Vehicle Owners”**

According to this legal provision, the total amount of the penalty and financial sanction, which should be paid to the victim-individual, may not exceed the amount of the insured sum by type of damage caused, which provided by Law.

The contested legal provision was recognised as not contradicting the Constitution since it assumes that in determining amount of the amount of penalty to be recovered from an insurance company for late payment of insurance to victim-individual in such case, the amount of the penalty for violation of the insurer’s obligation under this insurance payment, which was previously awarded by the court as a result of a reduction in the calculated amount, is taken into account.
